U.S. Trade Representative: Time to update TPA, support SMEs in global trade

U.S. Trade Representative Michael Froman urged Congress to pass bipartisan TPA legislation that would support small businesses integration into global supply chains. "You're probably heard of Gillette and Oakley, but what about El Dorado molds? That's a company in Sacramento County, CA, that builds plastic molds for Gillette razors and Oakley sunglasses, among other products that are made in America and sold around the world. U.S. Labor Department issues report on worker rights concerns in Honduras

The U.S. Department of Labor released a report on Feb 27 that raises serious concerns regarding the effective enforcement of labor laws in Honduras under the labor chapter of the Dominican Republic-Central America-United States Free Trade Agreement (CAFTA-DR). The AFL-CIO, which filed the initial complaint along with Honduran organizations, said it welcomed the report, but criticized the length of time it took, three years, to complete the report. "The delay is yet another reminder that our government is operating under a broken trade model and it's failing to protect labor rights," union President Richard Trumka said. The report provides recommendations to address the concerns and calls for the contact points established under Article 16.4 of CAFTA-DR to consult to develop and implement a monitoring and action plan.



MasterCard: Vietnam online shopping growth 2nd highest in Asia

Online shopping in Vietnam has grown fast in the past months with growth in the number of Vietnamese shopping online at the second highest rate in the Asia-Pacific region, according to the MasterCard Survey on Online Shopping 2014. The Vietnam online shopping 2014 survey made by the Vietnam E-commerce and Information Technology Agency under the Ministry of Industry and Trade showed that there were nearly 220 websites for shopping online with combined revenues of over VND1.66 trillion.

Labor Obligations in TPP and other Free Trade Agreements

USTR filed a Federal Register Notice announcing a dispute settlement proceeding under the CAFTA-DR FTA regarding Guatemala's failure to effectively enforce its labor laws, which illustrates the enhanced importance of labor obligations in TPP and other FTAs, based on the "May 10, 2007" bipartisan Congressional-Executive Agreement. The Agreement was a "breakthrough," with critical new labor obligations relating to fundamental labor rights being made subject to full dispute settlement. The "May 10" provisions were included in the FTA with Peru and, thereafter, Colombia, Panama and South Korea, and have been the starting point of the Obama Administration's labor negotiations in TPP.



West Coast port disputes drag on; business and political leaders urge resolution

With 50 container ships anchored off the West Coast, the eyes of the international trade community were focused on San Francisco to learn if U.S. Secretary of Labor Thomas E. Perez could break the impasse in contract negotiations between the ILWU and the PMA. The 29 affected ports handle nearly half of all U.S. maritime trade and more than 70 percent of imports from Asia. Port congestion issues could cost retailers \$7 billion this year. A 10-day shutdown could cost \$2.1 billion per day to the overall economy.



USTR Launches WTO Challenge to Extensive Chinese Export Subsidy Program

USTR Michael Froman announced that the U.S. has pursued dispute settlement consultations with China at the WTO concerning China's export subsidy program. Under this program, China seems to provide prohibited export subsidies to manufacturers and producers across seven economic sectors and dozens of sub-sectors located in more than one hundred and fifty industrial clusters throughout China known as "Demonstration Bases." China has given almost \$1 billion over a three-year period to "Common Service Platform suppliers" that agree to provide discounted or free services to Chinese companies, including exporters located in the Demonstration Bases, according to publicly available documents.

White House Summit on Cybersecurity and Consumer Protection, Feb 13, 2015



As a nation, the United States has become highly digitally dependent. Our economy, national security, educational systems, and social lives have all become deeply reliant on cyberspace. Our use of digital networks provides a platform for innovation and prosperity and a means to improve general welfare around the country and around the globe, driving unparalleled growth. But this dependency also creates risks that threaten national security, private enterprises and individual rights. It is a threat not just in the United States, but one that everyone, everywhere who is connected to cyberspace faces.

company officials. The Framework for Improving Critical Infrastructure Cybersecurity, offered by the U.S. Department of Commerce's National Institute of Standards and Technology (NIST) in February 2014, has provided Intel with a better understanding of its cyber risks and data security priorities, among other benefits, said Malcolm Harkins, the company's chief security and privacy officer, and Kent Landfield, its standards and technology policy director. The guidelines are intended to help enhance the cyber defenses of tech companies, utilities, banks and other businesses that work with critical infrastructure.



Vietnam taking prudent steps toward ASEAN Economic Community 2015

"Vietnam has always focused on protecting items related to agriculture," MoIT Minister Vu Huy Hoang said. "As a result, if we take prudent steps, we should not be afraid of the AEC." Wholesale and retail markets are particularly worrisome. "This is one step to take while following the roadmap, as we open the market gradually and cautiously. Besides, for each commodity, we have a different degree of openness," he said. Currently foreign wholesalers and retailers are operating in Vietnam but to a very limited extent, while the amount of goods and categories of goods subject to inspection and control is very large. "In addition, the opening of such facilities is considered very carefully by everyone from central to local authorities."



IMAX giant screen cinemas coming to Vietnam with CJ-CGV

IMAX's giant screen cinemas will enter Vietnam, following a two theater deal between IMAX and CJ-CGV, the South Korean company that is Vietnam's largest exhibitor. It acquired Megastar, Vietnam's largest multiplex cinema chain in July 2011. The first screen is set to open in a new construction project in Ho Chi Minh City (formerly Saigon). The other has yet to be determined. ...



GAA signs MOU with Vietnam Pangasius Association

The Global Aquaculture Alliance (GAA) established a collaborative effort to advance responsible aquaculture in Vietnam's pangasius sector through a memorandum of understanding (MoU) with the Viet Nam Pangasius Association (VNPA), which agreed to help identify and enroll processing plants, farms, feed mills and hatcheries in the GAA Best Aquaculture Practices (BAP) third-party certification program. ...



Vietnam's shrimp king seeks foreign strategic partner

Minh Phu Seafood Corp., which sells black tiger shrimp to Costco Wholesale Corp. and Wal-Mart Stores Inc., will seek to sell half of itself to foreign strategic investors to help fund overseas expansion. "We're looking for strategic foreign investors to help maximize our advantages and potential as our goal is to become a global shrimp company by 2020," CEO Le Van Quang, dubbed the "king of shrimp" by local media, said in an interview Jan. 24 in the Mekong delta province of Hau Giang. Mitsui & Co. Ltd. holds a 31 percent stake in the Mekong delta-based subsidiary. ...



Vietnam's catfish king ready to hook exports from free trade agreements

Hung Vuong Corp., which supplies frozen catfish to Wal-Mart Stores Inc. and Spain's Mercadona SA, will sell a company stake and spend at least \$100 million this year to expand production as Vietnam prepares to sign trade deals, said Chairman Duong Ngoc Minh. The company plans to double revenue to \$1.4 billion by 2017 and boost exports to at least 80 countries as Vietnam works to sign the Trans-Pacific Partnership accord and a free-trade deal with the EU.

Challenges for Vietnam's leadership in 2015

Experts on Vietnam characterized the Tenth Plenum of the 11th Party Congress held Jan 5-12 as a landmark event, suggesting that it has formed a new team of Vietnamese leaders for the next five years. Indeed, personnel issues were the focus. While experts focused mainly on the results of the vote of confidence among the Party Politburo leaders, the underlying significance has not received adequate attention. The evaluation of individual officials reflected the stances of political elites about the performance of the Party leadership and signaled the future direction. ...
