


#### Vietnam's 2016 Minimum Wage Proposal

The Minimum Wage Adjustment for 2016 is about 12.4%. It will be submitted to the Government for approval at the next regular meeting, and go into effect on Jan 1, 2016. The adjustment percentage is twice forecast 2016 GDP growth (6.2%), three times CPI inflation (1.8% in 2015 and 4% in 2016), and four times average annual productivity growth (3.3%). On the other hand, it is lower than increases in the past four years: 2012 (29%), 2013 (17.5%), 2014 (15%), 2015 (15.1%). The proposed MW in Region 1 for 2015 would be 3.5 million vnd/month. If present trends continue, the minimum wage in Region 1 will be about 5.1 million vnd/month in 2020. For the second year in a row, the proposed adjustment is within 1% of our trend line estimate.



#### Vietnam's private sector minimum wage is high, 58% of median wage

According to the World Bank, a key benchmark of minimum wages is the relationship to median wages, and for Vietnam the picture differs sharply between the government and private sectors. Vietnam's state sector wage is low by global and regional standards at around 30% of the median wage, while the private sector minimum wage is high, with the average ratio of minimum to median wage around 58%.



#### From the archives: Vietnam's "Minimum Wage Roadmap" to 2020

Written in August 2014, the article provides some background for the Minimum Wage 2016 discussion. MOLISA's Vice Minister said in 2014 that "the increases will be greater in 2016 and 2017." There was a "Minimum Wage Road Map," based on (1) Article 56 of the 2012 Labour Code " ... the Government will adjust the MW in order to preserve real wages;" and (2) "Party Central Committee Decision 23-KL/TW, May 29, 2012," Adjust the minimum wage more rapidly ... so that ... it will reach the level of the **Basic Needs Wage**.



### Pay increases depend on productivity - Bui Sy Loi

Bui Sy Loi, Deputy Head of the National Assembly's Social Affairs Committee, speaks to Ha Noi Moi (New Ha Noi) about salary reforms. **Will you please ex-plain why workers' average wages in Viet Nam are lower than their peers in the region and the world?** It is a universal truth that adjustment of a worker's minimum wage and their basic monthly salary depend on the economic growth rate, labour productivity and consumer price index (CPI) of the country.



### Role of Congress in TPP Approval explained in 3 slides


The first slide explains the basis of each branch's respective constitutional authority over trade policy; the second provides a history (list) of "trade promotion authority" granted by Congress to the President starting with the 1934 "Reciprocal Trade Agreements Act" up to the 2015 "Bipartisan Congressional Trade Priorities and Accountability Act" ("Trade Promoton Authority"); and the third slide is a timeline showing the process of concluding, reporting, submitting an implementing bill to Congress, the 90-day period for Congressional consideration and voting, and the notices required before the TPP enters into effect.



## VCCI Vu Tien Loc: "Không được để thất nghiệp gia tăng"

Hội đồng tiền lương Quốc gia đã họp vào ngày 25-8 sau khi thất bại trong vòng đàm phán đầu tiên về việc tăng lương tối thiểu vùng năm 2016. Chủ tịch Phòng Thương mại và Công nghiệp Việt Nam Vu Tiến Lộc gửi Thời báo Kinh tế Sài Gòn Online bài viết thể hiện quan điểm của giới chủ. Mời bạn đọc tham khảo. Vừa qua, những tranh luận gay gắt xung quanh cuộc đàm phán tăng lương tối thiểu vùng năm 2016 đã thu hút được sự quan tâm rộng rãi của dư luận. Trong khi Tổng liên đoàn Lao động Việt Nam đề xuất mức tăng là 16%, thì phần lớn các hiệp hội doanh nghiệp trong và ngoài nước lại cho rằng, mức tăng chỉ khoảng 6 - 7% mới là hợp lý.

#### World Bank: Are minimum wages too high?



The World Bank's most recent update on Vietnam's economic developments concluded that (1) a high minimum wage, if enforced, will reduce formal employment; (2) outside the government sector, Vietnam's minimum wages have risen rapidly in recent years, [far] outstripping productivity growth, [which has been practically nil]; and, (3) [yes], Vietnam's private sector minimum wage is high relative to other countries.



## \$3 billion FDI to meet TPP yarn-forward rules-of-origin

The TPP has encouraged many foreign textile and garment firms to boost investments in Vietnam. The yarn-forward rule under the TPP requires that the yarns, fabrics and final garments to be exported within the TPP should be produced in the TPP member countries. So, apparel producers in Vietnam will have to use domestic material or import it from the TPP members instead of China if they want to benefit from the multilateral trade pact.



### Vietnam expects September restart for TPP talks

Deputy Minister of Industry and Trade, Tran Quoc Khanh, said that he expects TPP talks to resume in September. He made the remarks after returning from a visit to Washington, where he discussed outstanding bilateral issues with USTR officials.



#### Vietnam's textiles sector in the TPP

TPP negotiators made "significant progress" on textile issues at negotiations last month in Hawaii, where Vietnam placed more emphasis on getting duties eliminated immediately on near.y 1,600 apparel tariff lines rather than on rules of origin that are meant to deliver the benefits of the trade deal only to TPP countries.



### Foreign firm exodus from China to Vietnam may be delayed

A Standard Chartered Bank study highlighted the fact that increasingly-competitive Vietnam is now the "best choice" for China-based investors who want to relocate their production base. But the exodus may be delayed by Vietnam's restrictions on imports of used machinery and equipment.



### NZ Trade Minister Tim Groser: "autos and dairy are the two issues"

"There is a very strong shared informal understanding that the TPP has got to be done in weeks, not in months. There are essentially two sticking points: the deal on autos and the deal on dairy. And Canada is exposed both on dairy and on autos in a very , very intriguing and difficult way."



#### Vietnam's start-up queen ... 3rd time is a charm

Thuy Truong's third business, a social messaging app called Tappy, is her biggest success. "When you come to an event or a business venue, you can use Tappy to fin and interact with people around you. Basically, it turns the venue into a virtual community to allow people to talk in groups or talk privately. Some ten months after it was launched, Tappy was acquired by Weeby, a mobile gaming technology company based in Silicon Valley, for "an undisclosed seven-figure sum." Ms. Truong now works as Weeby's director for business development in Asia.

### TransPacific Partnership's impact on Vietnam's economy

Herb Cochran, Executive Director of the American Chamber of Commerce Vietnam (AmCham Vietnam), tells the Vietnam Economic Times's Hoang Thu about the TPP's impact on Vietnam's



economy. Vietnam accounted for 20% of U.S. imports from ASEAN in 2014 and could account for over 30% by 2020. Total trade between Vietnam and the U.S. could double from \$36 billion in 2014 to \$72 billion in 2020.
