TPP Entry into Force: two years, three scenarios

The TPP will enter into force (1) 60 days after all 12 original TPP governments have completed their "applicable legal procedures," and notified the "Depository;" (2) if all 12 haven't notified within two years after signing, then the TPP will enter into force two years and 60 days after signing, if at least six TPP governments, accounting for 85% of the combined 2013 GDP of the 12 original signatories, have notified; or (3) if neither of the preceding are applicable, then the TPP will enter into force 60 days after at least six TPP governments, accounting for 85% of the combined 2013 GDP of the 12 original signatories, have notified.



Vietnam's economy increasingly relies on FDI exports

Vietnam's GDP is about \$198 billion (WB); exports are about \$162.1 billion. Exports from FDI factories account for \$115.1 billion, 71% of total exports. And 90% of the value of Vietnam's exports are imported components and materials. In 2009, FDI accounted for 41% of Vietnam's exports.

Walmart has 11,164 stores in 27 countries. And more than half of Walmart's stores, 6,357, are outside of the U. S. TPP will help firms gain access to 3.2 billion middle class consumers by 2030

By 2030, the Asia-Pacific region will have 3.2 billion middle class consumers. Global middle-class spending should rise from \$21.3 trillion in 2009 to \$55.7 trillion in 2030. Asia's share should increase from 23% in 2009 to 59% in 2030. Growth of both multinationals, local companies, and the global economy will depend increasingly on emerging market consumers, especially in the Asia-Pacific and Trans-Pacific Partnership Region.



News and Issues



U.S. - ASEAN Summit, Feb 15-16, 2016

The summit will take place at Sunnylands in Rancho Mirage, California on February 15-16, 2016. This unprecedented gathering - the first hosted by the United States with the ASEAN leaders - builds on the deeper partnership that the United States has forged with ASEAN since 2009 and will further advance the Administration's rebalance to Asia and the Pacific.



12th National Party Congress, Jan 20 - 28, 2016

Over 1,500 delegates are attending the 12th Party Congress in Hanoi, representing over 4.5 million Party members. Party General Secretary Nguyen Phu Trong said 68 centrally-run Party organisations sent their reports on the 12th National Party Congress's draft documents. The Viet Nam Fatherland Front, social organisations, administrations at different levels and many sectors held workshops and conferences to collect recommendations.



ANA buys stake in Vietnam Airlines

ANA's first investment in a foreign flag carrier, and the first time Vietnam Airlines receives funds from a foreign company. ANA likely was selected for its ability to snare demand for business travel between Vietnam and the Americas and elsewhere via Japan, demand that is likely to surge after the TPP takes effect. Visitor traffic from Vietnam to Japan has more than quadrupled in the past five years. Total travel between the countries has grown by around 50% annually for the past three years. ...

ITC Public Hearings on Impact of TPP, Jan 13 -15



Twenty-five witnesses, led by House Ways & Means Ranking Democrat Sander Levin, Senator Sherrod Brown, Ambassadors to the U.S. from Singapore, Japan, and Peru, provided testimony to the U.S. International Trade Commission on the "Trans-Pacific Partnership Agreement: Likely Impact on the U.S. Economy and on Specific Industry Sectors" in three days of public hearings, Jan 13-15. Top U.S. business groups endorse TPP, with reservations

Though business groups' support was expected, their roles in helping the White House lobby Congress to pass the deal is considered crucial, particularly in convincing Republican leaders to move forward with a final ratification vote this year. The business groups said they would fight for the deal in Congress, but the direct message in each of the statements was to the administration, not congress.

NETFLIX plans to enter Vietnam



At the opening keynote at the Consumer Electronics Show, Netflix CEO confirmed that the streaming platform will expand to yet another major market - Vietnam - along with other countries. As of 2015, the digital economy phenomenon is live in more than 70 million homes, and users clocked a total of 42.5 billion hours of streaming video for 2015.

Trading Views: Public Hearing Debates on key issues in TPP

"The 90-day period was established to facilitate an intensive and informed debate over the merits of TPP as negotiated, as well as the necessity for any modifications to the agreement, before the agreement is signed," said Rep. Sander Levin. "Ways and Means Democrats look forward to engaging fully and meaningfully with stakeholders, the public, our colleagues and the Administration during this period. As part of that engagement, we are organizing a series of in-



depth public hearings to assess the merits of the proposed agreement, zeroing in on those issues that are of particular importance or concern to us and our fellow Democratic colleagues. These sessions will help to build a full foundation of information and transparency before Congress votes on the agreement." The first debates focused on environmental, investment (including tobacco), IP and access to medicines, and currency manipulation.



TPP Issue Analysis - Currency Manipulation

Currency manipulation has cost U.S. workers millions of jobs - and just a few years ago was estimated to be responsible for as much as half of excess unemployment in the United States. It has contributed to stagnant wages for the middle class and to inequality in the United States. Former Treasury Secretary Larry Summers recently asserted that the United States should use the leverage provided by TPP to address "inappropriate producer subsidies - including through manipulated exchange rates."
