TPP would help small and medium exporters

98% of U.S. exporters are actually small and medium-sized enterprises (SMEs), and these smaller traders account for over one-third of U.S. exports. SMEs that export are also economic powerhouses. They hire more employees, pay higher wages, and are more resilient and productive than their non-exporting counterparts. TPP offers significant untapped potential to drive growth and support good jobs by increasing small business trade.



Customs checks unimproved, delays, high costs

The reforms in Vietnam's management procedures and control have not yet seen significant changes, according to the findings of the American government's USAID Governance for Inclusive Growth (GIG) program. Specialised management of import goods was a major obstacle, which creates extra costs and time loss for enterprises, Nguyễn Đình Cung, CIEM head, was reported as saying by [chinhphu.vn](#).



Smart traffic system proposed for HCM City

Shawn Smith, president of Vigilant Solutions, proposed a smart transportation system with a network of 12,000 fixed and mobile cameras installed around the city. San Francisco, which uses the system, has recorded an average of 5,600 cases of traffic violations each day, helping the city collect \$2.8 million in fines. The project would be funded with US\$300 million borrowed from investment bank Morgan Stanley.



Democratic Whip Steny Hoyer on TPP vote in lame duck session

Democratic Whip Steny Hoyer skirted a question about how he would vote on TPP, should it come to the floor this fall, by simply saying that it would not. "It's not going to come to a vote."

Vietnam served low-quality coffee - consumer protection group warns

Nearly one third of local coffee products were either of extremely low quality or even fake, according to a survey by the Vietnam Standards and Consumers Association (Vinatas) in Hanoi, HCM City, Binh Duong and Soc Trang,



Korea's Hyosung Group to make Vietnam its global production base

Hyosung has invested about US\$1.2 billion near HCMC since 2007 to establish its main production base for global markets. The firm employs about 6,000 Vietnamese workers and accounts for some 0.7% Vietnam's yearly export amount.



Senator Hatch: TPP can get done in the lame duck session

Senate Finance Committee Chairman Orrin Hatch said Wednesday that Congress will pass a sweeping Asia-Pacific trade agreement before the end of the year, according to a report. "I think we're going to get it done in lame-duck," Hatch said.



Airports expansion to meet air travel growth

The number of air travelers in Vietnam reached about 26.4 million in the first eight months of this year, up 27.3% from a year earlier. Foreign air travel visitors also rose 28.5% year on year to around 5.4 million. Expansion at Tan Son Nhat, Noi Bai, and a new airport, Long Thanh, will ease the pressure. However, the expansion proposals at Tan Son Nhat and Noi Bai have not been approved yet, and the first phase of construction at Long Thanh will not start until 2019.



Vietnam's process of TPP ratification and implementation legislation

After the April Monthly Government [Cabinet] Meeting, Resolution 33/NQ-CP, May 9, 2016, para. 4 explained Vietnam's process of TPP ratification and implementation legislation, which could take up to two years from the Feb 4, 2016 signing date. There will be a proposal for an omnibus TPP implementation bill, " ... reported to the Government [Cabinet] at the regular meeting in December 2016. The Prime Minister signs the Proposal before submitting to the President to consider and decide the submission of the Proposal to the National Assembly" for review, consideration, and ratification.



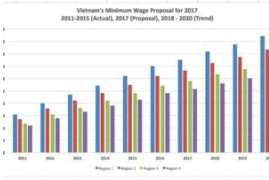
Vietnam looks to revise apparel sector strategy for more growth with TPP

Vietnam's export value for textiles and apparel was targeted to hit \$20 billion by 2020, but exports already surpassed \$27 billion in 2015 and are expected to reach \$31 billion by the end of 2016. Between 2010 and 2015, growth in the garment sector has been up 15 percent per year.



Think You Bought Red Snapper? Don't Be So Sure

When the environmental group Oceana conducted a large study of the issue three years ago, the results were shocking. Scientists performed DNA tests on more than 1,200 samples from nearly 700 different stores and restaurants in 21 states. One out of three fish were mislabeled, in violation of Food and Drug Administration regulations, and the numbers were even worse in big cities such as New York, Los Angeles and Boston.



Vietnam's 2017 Minimum Wage Proposal

The proposed Minimum Wage Adjustment for 2017, the fourth since the establishment of the National Wage Council under the revised Labour Code of 2012, is an average increase of 7.3%, down from 12.4% in 2016. It will be submitted to the Government for discussion and approval at the next regular meeting, scheduled for September, and go into effect on Jan 1, 2017.



TPP is coming: [Draft] Statement of Administrative Action submitted to Congress

The White House put Congress on notice that it will be sending lawmakers a bill to implement the Trans-Pacific Partnership agreement - a move intended to infuse new energy into efforts to ratify the trade pact.



Textile giant Texhong is charging ahead in Vietnam, despite TPP uncertainties

For Texhong Textile Group, even as uncertainty looms over the free trade pact, the company is firmly committed to further expansion in its southern neighbor. Texhong, one of the world's largest yarn suppliers, has been aggressively building up production capabilities in TPP signatory Vietnam. Founder and Chairman Hong Tianzhu has said one of the main intentions of investing there is to deal with the trade agreement. But even without the TPP, the competitiveness of the Vietnam operation "is very strong, among all Southeast Asian nations and even compared to Chinese production bases."



Administration readies one last push for TPP in lame duck session

Although the administration's push will begin in September, no vote will occur until after the Nov 8 elections. Just as the White House Democrats and congressional Republicans mostly agree on the economic benefits of trade, they have parallel political interests in delaying debate. Republicans do not want to provoke attacks from their presidential nominee, Donald J. Trump or hurt other Republican candidates. Mr. Obama does not want to make trouble for the Democratic nominee, Hillary Clinton, who has struggled to persuade voters of her sincerity in switching from support of the pact to opposition.



"Country-specific implementation plans ... to develop political support for TPP" - Senator Hatch

"It is essential that the Obama administration work to reach country-specific plans identifying the changes that our trading partners must and will make to their laws, regulations, and practices in order to meet their key TPP obligations. These country-specific implementation commitments would provide a valuable tool for resolving shortcomings and ambiguities in the agreement, while helping to build confidence in the Congress that TPP will be implemented fully and faithfully by our trading partners.

TPP Prospects in the U.S. Congress Lame Duck Session



"Everything in Washington is impossible until it is inevitable," Ambassador Froman said. But House Speaker Paul Ryan said on Aug 4 that TPP won't get a vote in Congress this year because there isn't enough support. He said there is no point in bringing up the TPP after the November elections because he doesn't see how the Obama administration can build enough support for the agreement. Nevertheless, the Administration is making a "whole of government" effort to pass the TPP this year
