TET Lunar New Year, 2017 . Jan 26 - Feb 1 - Seven Days

Traditionally, there are several main days of celebration: Tết Lunar New Year's Eve (Jan 27), and The First (Jan 28), Second (Jan 29), and Third (Jan 30), Fourth (Jan 31), and Fifth (Feb 1) of Tết Nguyên Đán. Vietnamese traditionally celebrate Tết from the fifteenth day of the twelfth lunar month to the fifteenth day of the first lunar month. And, even today, business slows two weeks before and two weeks after TET. The 2017 TET Holidays in Vietnam are from Thu, Jan 26 to Wed, Feb 1 inclusive.



Vietnam to apply extensive area code changes in 2017

Area code changes in Ho Chi Minh City, Hanoi, Dong Nai, Binh Duong, and a number of other provinces will take place on June 17, 2017. The new area codes will be applied for 59 cities and provinces in three phases, from February 11 to June 17, with steps taken to ensure the change will not confuse the public, the Ministry of Information and Communications announced. But there are other concerns, such as the need to reprint packaging or business cards once numbers are changed, costing quite a sum.



Korea's Kolon Industries to invest \$1 billion in Binh Duong, Vietnam

To develop a factory manufacturing airbags and industrial fabric for automobile tires, aiming to capture a larger share of the domestic and international market. Kolon Industries will rent a 42-hectare area in Becamex IDC's expanded Bau Bang Industrial Park to construct the factory. The long-term investment plan has three phases. The first phase, with a total investment capital of \$220 million, will be disbursed in the 2017-2018 period, the second phase will last until 2026 with \$600 million. The \$1 billion mark will be hit sometime after 2026.



TAL: Back to the future through Vietnam

TAL Apparel's \$50 million plant in Vietnam opened in October, can produce 16,000,000 shirts annually, in 100,000 variations, when output ramps up in the future, part of Vietnam's bid to join apparel global supply chains and employ millions. But the biggest news is across the road, where construction is under way on a \$320 million TAL textile mill, part of an integrated operation from yarn dyeing to fabric weaving to finishing



Chile, Swaziland the 97th and 98th WTO members to ratify the Trade Facilitation Agreement

Chile and Swaziland submitted their instruments of acceptance to WTO Director-General Roberto Azevêdo, making them the 97th and 98th WTO members to do so. The TFA will enter into effect when 2/3 (108) of the 162 WTO members have ratified the agreement.



Homeland Security Chief Cites Phishing as Top Hacking Threat

Why are people still such suckers for phishing? At a security event in New York this week, top law enforcement officials shared their concerns, and their biggest pre-occupation was plain old e-mail. "The most devastating attacks by the most sophisticated attackers almost always begin with the simple act of spear-phishing," Homeland Security Secretary Jeh Johnson told the crowd, referring to malicious emails that appear to come from a credible source. He has a point. The debacle over leaked emails from Hillary Clinton's campaign chairman began when the chairman, John Podesta, fell for a fake Gmail message. So what can we do about it?



After the Trans-Pacific Partnership, a perspective from Vietnam

President Obama has announced that he will no longer seek passage of the Trans-Pacific Partnership (TPP) in Congress, leaving the fate of the treaty in the hands of President-elect Trump and the Congressional Republican leadership.

This matters for two reasons. First, within a decade, four of the five largest economies of the world will border the Pacific Ocean. The United States will be able to continue its global leadership role only if it retains an integral, active presence in the Pacific. Second, if the United States retreats from the region, as a defeat of TPP in Congress would surely signal, an emboldened China will ever more aggressively seek to displace America.



**Vietnam delays TPP ratification, but not international integration**

"The United States has announced it suspends the submission of TPP to the Congress so there are not sufficient conditions for Vietnam to submit its proposal for ratification," Prime Minister Nguyen Xuan Phuc told the National Assembly on Nov 17. "We are ready to join the TPP but with or without this trade deal, Vietnam will remain on the international integration path."

TPP Entry into force: two years, three scenarios

As the data in the table shows, both the U.S. (60.3%) and Japan (17.7%) must ratify for the TPP to enter into force, since the required 85% can't be reached without both of them. Two of the three "5%" countries, Canada (6.6%), Australia (5.6%), and Mexico (4.5%), must ratify, for the same reason. And at least two of the other TPP countries "1%" countries must also ratify to reach the required six TPP governments and 85% of the combined GDP in 2013.

**Looking back two years ago ... New U.S. Congressional leaders support TPA, TPP**

Since the new Congress was sworn in on Jan 6, 2015, leaders of both the House and Senate have cited trade as a top bipartisan priority for the new year. In new U.S. Senate Majority Leader Mitch McConnell's (R-KY) first official remarks, he noted the president has "already indicated a willingness

to work with us on trade and infrastructure and comprehensive tax reform. Navigating the political pitfalls won't be easy. But passing these types of things would represent a win for the American people." In separate remarks, McConnell and House Speaker John Boehner (R-OH) said they expect a bill on Trade Promotion Authority to be introduced soon. The new leadership doesn't guarantee passage, but it sidelines the biggest foe, former U.S. Senate Majority Leader Harry Reid (D-NV).

Obama Administration gives up on TPP ... ?



On Fri, Nov 11 in Washington DC, "Republican and Democratic leaders in Congress told the White House they wouldn't advance the TPP in the election's aftermath," during the lame duck session, "and Obama administration officials acknowledged it has no way forward now." Both presidential candidates opposed the TPP.



U.S. to investigate alleged China steel transshipments via Vietnam

The Department of Commerce is expected to launch a formal investigation into whether Chinese steel companies are shipping steel through Vietnam to avoid U.S. import tariffs. Independent trade data supports what the steelmakers are alleging. In the first six months of 2016, shipments of steel from Vietnam to the U.S. increased to 312,329 tons, from 25,756 tons in the year earlier period, according to data firm Global Trade Information Services.



Mainstream Renewable Power, GE to Develop, Build and Operate Wind Power Plants in Vietnam

The \$1.5 billion of wind projects are expected to comprise both greenfield and partially developed sites, to include co-operation with local and international developers, and will receive financing through a Mainstream and GE Energy Financial Services joint development agreement. The aim is to compliment the 1GW initiative that GE and Ministry of Industry and Trade signed in May 2016 to accelerate large-scale Vietnamese wind project buildout.



Samsung Turns Farmers Into Bigger Earners Than Bankers

A few years ago, Nguyen Thi Dung was feeding chickens and planting rice to make ends meet in one of the poorest areas in Vietnam. This year, she expects to earn more than a typical stockbroker in the country. The difference? Samsung. "Our lives have improved dramatically since Samsung came," says the 57-year-old ex-farmer, who now rents rooms and sells groceries to assembly line workers, and expects to earn the equivalent of \$68,000 this year. "I want to buy a car and have my children drive me around."



Prime Minister approves National Committee on Trade Facilitation

On Oct 4, 2016. The NCTF, based on the WTO Trade Facilitation Agreement Art. 23.2, will facilitate both domestic coordination and implementation of the provisions of the TFA. The establishment of the NCTF, conclusion of a Customs Mutual Assistance Agreement between Vietnam and U.S. customs authorities, and establishment of meaningful public-private consultations regarding import/export procedures in Vietnam have been the top priorities of the Vietnam Trade Facilitation Alliance, a partnership between USAID, VCCI, and AmCham.



Prime Minister approves Trade Facilitation Agreement Implementation

Plan on Oct 13, under the leadership of Deputy Prime Minister Vương Đình Huệ. With the WTO TFA expected to enter into effect soon, the plan includes Working Groups for TFA commitments, including transparency, fees and procedures, freedom of transit, customs cooperation and mutual assistance, special and differential treatment, institutional arrangements, etc. When implemented, the Trade Facilitation Agreement will reduce Vietnam's trade costs by 20%, according to a WTO report.
