Secretary Kerry and Ambassador Vinh on Vietnam-U.S. Relations

Secretary Kerry said, "It is clear that we have turned some very important corners. There are hard choices still to make for our relationship to reach its full potential, but now we can say definitively, because so many Vietnamese and Americans themselves refuse to let our past define our future, Vietnam, a former adversary, is now a partner with whom we have developed increasingly warm, personal and national ties." He and Ambassador Vinh spoke at the April 26-28, 2016 LBJ Presidential Library "The Vietnam War Summit." The goal was to shed definitive light on the war, and its lessons and legacy. Kerry added, "That is our shared legacy, and is one that I hope we will continue to strengthen in the years to come."



WTO DG visits Vietnam, highlights Trade Facilitation Agreement

"For Viet Nam, the Trade Facilitation Agreement could reduce trade costs by as much as 20%. Cutting a fifth off the cost of trading would make a huge difference. It will help boost trade flows. It will support SMEs to start exporting. And, in a time when production chains have been globalised, it will help Vietnam's economy to connect to cross-border production networks." Vietnam ratified the TFA in Dec 2015.



India ratifies the WTO Trade Facilitation Agreement

Ratifying the WTO Trade Facilitation Agreement will help boost economic growth by reducing trade costs and supporting integration into the global economy. India is the 76th WTO member to accept the TFA, which will enter into effect when 2/3 (108) of the 162 WTO members have ratified the agreement. ...



U.S. Steel files ITC complaint against Chinese steel producers

United States Steel Corporation filed a complaint with the U.S. International Trade Commission (ITC) to initiate an investigation against the largest Chinese steel producers and their distributors. The complaint alleges illegal unfair methods of competition and seeks the exclusion of all unfairly traded Chinese steel products from the U.S. market. The complaint alleges three causes of action: illegal conspiracy to fix prices, theft of trade secrets, and the circumvention of trade duties by false labeling.



Statement by the Press Secretary on the President's Travel to Vietnam and Japan

The President will travel to Vietnam and Japan May 21-28, on what will be his tenth trip to Asia. This trip will highlight the President's ongoing commitment to the U.S. Rebalance to Asia and the Pacific, designed to increase U.S. diplomatic, economic, and security engagement with the countries and peoples of the region. The President will first visit Vietnam, where he will hold official meetings with Vietnam's leadership to discuss ways for the U.S.-Vietnam Comprehensive Partnership to advance cooperation across a wide range of areas, including economic, people-to-people, security, human rights, and global and regional issues. In Hanoi, the President will deliver a speech on U.S.-Vietnam relations. During meetings and events in Hanoi and Ho Chi Minh City, the President will discuss the importance of approving the Trans-Pacific Partnership this year. The President also will meet with members of civil society, the Young Southeast Asian Leadership Initiative, entrepreneurs, and the business community.



Vietnam suffering worst drought in almost a century

A crippling drought in Vietnam threatens to create a shortage of food and water for two million people. Vietnam is going through its worst drought in almost a century amid intense and prolonged El Nino conditions. Low water levels in the Mekong River have caused seawater to flow 90 kilometers into the basin, the furthest recorded in history.



Drought killing Vietnam rice crops compounds Mekong water crisis

The dry spell in the once-fertile Mekong Delta is devastating food supplies in southern Vietnam and threatening to reduce global exports of rice, seafood and coffee. It is also compounding a Southeast Asia water shortage along a 3,000-mile river that runs from Tibet to Thailand to the East Sea [South China Sea], as climate change and too many dams [in China and Laos] erode livelihoods for millions of farmers in Vietnam's Mekong Delta.



Half of Vietnam's rice exports go to China

Vietnamese enterprises shipped more than four out of 8.3 million tons of rice for export last year to China via formal [1.98 million tons] and informal [2.02 million tons] channels. Meanwhile, data of the Ministry of Agriculture and Rural Development (MARD) indicated more than 30% [1.98 million tons] of the 6.6 million tons of rice shipped abroad through official channels last year went to the world's most populous country. [so 2.02 million tons went through informal channels]."



New rule-based order needed to save the Mekong

As Vietnam suffers its worst drought in nearly a century, debates have been reignited over the mega dams built along the Mekong. The Vietnamese part of the Mekong Delta, the Cuu Long region, accounts for 33% of Vietnam's agricultural sector and 90% of its rice exports, half of which go to China.



TPP Trade Opportunities from the U.S.

The TPP will create great opportunities for trade by eliminating more than 18,000 tariffs on U.S.-made products sold overseas and establishing the highest standards on labor, the environment, and the digital economy ever to be included in a trade agreement. The agreement's impact on trade between the U.S. and the five TPP countries with which the United States does not yet have a Free Trade Agreement will be particularly profound. These include large, well-established markets like Japan, where U.S. companies exported \$66.8 billion in goods, and growing markets like Malaysia and Vietnam, where U.S. goods exports totaled \$13 billion and \$5.7 billion in 2014, respectively.

New YKVN Partners, Of Counsel And Counsels

U.S. to focus on implementing commitments in TPP, especially labor

Looking ahead, we are already working with our TPP partners on implementation and monitoring and enforcement mechanisms," Froman said. "So we've had teams go out to our TPP partners over the course of the last several weeks to talk through what it is they can do to bring their systems into compliance with TPP obligations."



Fish Inspection transferred from U.S. FDA to USDA

The U.S. Food and Drug Administration has completed the transfer of the domestic and import inspection program for siluriformes fish and fish products to the U.S. Department of Agriculture's (USDA) Food Safety and Inspection Service (FSIS). Siluriformes fish include fish commonly known as "catfish." The primary inspection responsibility was transferred to FSIS on March 1, 2016 for domestic producers and on April 15, 2016 for importers. FSIS is already working with firms associated with these types of fish and fish products.



U.S. FDA cracks down on imports of shrimp from Malaysia

The FDA announced that its District Offices may detain, without physical examination, imports of shrimp and prawns from peninsular Malaysia due to testing that found that approximately one-third of imports from peninsular Malaysia contained residues of nitrofurans and/or chloramphenicol.



Finance Committee Chairman explains process of TPP ratification

The signing ceremony ... is just beginning. We'll debate the merits of each and every provision of this agreement and consider how it will impact workers and job creators in our country and how it will affect the health of our economy. I will focus on the process by which Congress will consider and debate this agreement ... it is important that people, including members of Congress, the administration, stakeholders, and the media, have a full understanding of how this is going to work. As I've said many times, the TPP is an extremely important agreement, and we need to get it done. But, given that importance, we need to focus more on getting it right than on getting it done fast.
