Senate Finance Committee Chairman remarks on TPP

In a speech on the Senate floor, Finance Committee Chairman Orrin Hatch said, "The United States only has one change to negotiate, consider, and implement the TPP. We have to get it right." The negotiating objectives we included in our TPA law aren't just pro forma; they aren't suggestions or mere statements of members' preferences. They represent the view of the bipartisan majority in Congress. Senator Hatch has laid out three criteria for deciding whether to support the TPP. First, he said, the agreement must be balanced and meet the U.S. negotiating objectives established under TPA. Second, the administration needs to prove to Congress that

Siemens CEO sees opportunities for more business in Vietnam

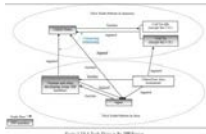

Vietnam Customs' Official Letter of Instructions, Oct 5, 2015

To insure transparency, consistency, and regulatory coherence, the General Department of Vietnam Customs hereby requests local Departments of Vietnam Customs to strictly implement the customs laws and regulations, including special emphasis on the following matters, which the business community and associations raised during consultations in September.



Vietnam's TPP ratification to take up to 2 years: lead negotiator

It will take up to two years for the Trans-Pacific Partnership (TPP), which was reached after five years of talks by 12 countries in Atlanta on Monday, to be ratified in Vietnam, the lead Vietnamese negotiator of the trade deal said. "other [TPP] countries also pledge to provide technical assistance to Vietnam in fulfilling its commitments," he added.



TPP: The end of the beginning

The TPP is still a promise, not yet a reality. The political deal that brought Trans-Pacific Partnership (TPP) negotiations to a successful conclusion on Oct 5, 2015 was a landmark achievement. But now the legislatures of 12 TPP member countries will need to review, debate, approve and implement it.



General Department of Vietnam Customs Official Letter, Oct 5, 2015

TPP, other FTAs put pressure on Vietnam port expenses

"Vietnam must do more to make its cargo operations more competitive with its regional rivals." Vietnam's logistics costs, at 25% of its GDP, are higher than those of regional competitors. Most of Vietnam's international trade is conducted through the Cai Mep cluster of terminals near the southern metropolis of HCM City.



More Vietnamese students study abroad

Increasing numbers of university-aged Vietnamese students are pursuing degrees abroad. They see high value in degrees from American, British, and Australian schools. Further, many remain in their host countries after graduation, attracted by high paying jobs matching their skill sets. Two factors can reverse this loss of talent: growth in domestically owned high-value-added industries and continued improvement of domestic universities.
