Prime Minister's meeting with the business community

Prime Minister Nguyen Xuan Phuc pledged to create a level playing field for enterprises from all economic sectors given the business community's concerns over discrimination between the State and private sectors.



U.S., China sign MOU to end China's export subsidies

The agreement is a step by Beijing to reduce trade frictions with the United States that range from steel and agricultural products to technology and banking. The Obama administration has sought to boost enforcement of alleged trade violations in part to rally support for new trade agreements, including the Trans-Pacific Partnership.



USTR: changes to existing U.S. law required to comply with TPP

The U.S. Trade Representative's office published a description of changes to existing U.S. laws required to comply with the rules of the Trans-Pacific Partnership. The one-page document, which is required by the trade promotion authority law, includes only one entirely new legal change under the trade pact, which will require that a customs fee - the merchandise processing fee - not be levied on an ad valorem basis.



New rule-based order needed to save the Mekong

As Vietnam suffers its worst drought in nearly a century and Cambodia faces a water shortage that could jeopardise the livelihoods of 1.5 million people, debates have been reignited over the mega dams built along the Mekong. The Vietnamese part of the Mekong Delta, the Cuu Long region, accounts for 33% of Vietnam's agricultural sector and 90% of its rice exports.



Customs: 1,000 containers abandoned at Hai Phong port

Nearly 1,000 containers have been left at the port for months, the majority for up to 4 years, causing billions of dong in inventory management, transportation, storage and pollution.



Vietnam's National Assembly ratified agreement on visa reciprocity

Under the bilateral agreement, based on an exchange of diplomatic notes, Vietnam will issue one-year, multiple-entry visas to U.S. citizens, as the U.S. issues one-year, multiple-entry visas to Vietnamese citizens planning temporary visits to the U.S. for business or tourism.



Growth engines and development traps

Transitioning to a 'knowledge-based economy', which presumably means an economy in which the share of income earned from human capital is high and rising, is a worthy goal. Unfortunately, many of the countries that talk loudest about the need to transition to a knowledge-based economy are the most resistant to educational reform.



ASEAN AmChams Business Outlook Surveys

For more than a decade, the ASEAN AmChams Business Outlook Survey has been a key barometer of U.S. business sentiment. Executives from American and foreign enterprises as well as thought leaders from governments, academia, and non-government organizations across ASEAN rely on the survey to understand opportunities and challenges for American businesses across the region. The surveys incorporate the responses of nearly 500 senior business executives representing U.S. companies in all ten ASEAN markets.



National Assembly concerned about food safety in Vietnam

Even though Vietnam has a detailed legal framework and laws related to food safety and hygiene, the problem remains, said Le Thi Nga, deputy chairwoman of the NA Justice Committee. "Unhygienic food is causing more illnesses, lowering economic competitiveness and badly affecting the country's image," Nga said.



U.S. firms show strong interest in Vietnam

Over 50 U.S. companies attended the "Meet the USA" conference held by Vietnam's Ministry of Foreign Affairs and the US Embassy to Vietnam. US Ambassador to Vietnam Ted Osius said that he "would like to see the US become the number one investor in Vietnam," but stressed that US firms were seeking more improvements in the local business climate.



Vietnam to win "fine flavor" cocoa status

Vietnam is to become the 2nd Asian nation to be recognized by the International Cocoa Organization (ICCO) as a "fine flavor" cocoa origin. Vietnam produces cocoa on more than 11,000 hectares in three cocoa-growing regions: Western Highlands, Mekong Delta, and Southeastern Region. ...



FDI representatives concerned about Circular 23

At a recent meeting of City Leaders and FDI Business Associations, FDI investors made very candid comments about the procedures and the problems encountered when doing business in Vietnam. 63% of Japanese companies said the lack of transparency in the administration is a risk when investing in Vietnam. The Japanese Business Association (JBAH) representative said Circular 23 will hinder Japanese enterprises' plans to invest in Vietnam...



U.S. remains the leading source of FDI

globally, according to the OECD. Data shows U.S. FDI outflows accounted for 39.5% of all OECD FDI outflows in 2013, and 37.6% of all OECD FDI outflows in 2014, the most recent year for which data is available. And over the years, U.S. has accounted for 44% of the OECD FDI "stock" by 2014. OECD FDI outward flows in 2014 were \$895.428 billion, of which U.S. FDI outward flows were \$336.935 billion, or 37.6%.



Sander Levin, Top House Democrat on trade, opposes TPP

The leading House Democrat on trade policy said he opposes the TPP, underscoring the hostile political environment. He said he doesn't support the TPP in its current form because it contains insufficient provisions to protect labor, lacks binding rules to prevent currency manipulation, and could ease the movement of the auto industry from his home state of Michigan to Mexico.



Finance Committee Chairman explains process of TPP ratification

The signing ceremony ... is just beginning. We'll debate the merits of each and every provision of this agreement and consider how it will impact workers and job creators in our country and how it will affect the health of our economy. I will focus on the process by which Congress will consider and debate this agreement ... it is important that people, including members of Congress, the administration, stakeholders, and the media, have a full understanding of how this is going to work. As I've said many times, the TPP is an extremely important agreement, and we need to get it done. But, given that importance, we need to focus more on getting it right than on getting it done fast.
