#### Vietnam's National Assembly ratified agreement on visa reciprocity

Under the bilateral agreement, based on an exchange of diplomatic notes, Vietnam will issue one-year, multiple-entry visas to U.S. citizens, as the U.S. issues one-year, multiple-entry visas to Vietnamese citizens planning temporary visits to the U.S. for business or tourism.



#### National Assembly concerned about food safety in Vietnam

Even though Vietnam has a detailed legal framework and laws related to food safety and hygiene, the problem remains, said Le Thi Nga, deputy chairwoman of the NA Justice Committee. "Unhygienic food is causing more illnesses, lowering economic competitiveness and badly affecting the country's image," Nga said.



#### U.S. firms show strong interest in Vietnam

Over 50 U.S. companies attended the "Meet the USA" conference held by Vietnam's Ministry of Foreign Affairs and the US Embassy to Vietnam. US Ambassador to Vietnam Ted Osius said that he "would like to see the US become the number one investor in Vietnam," but stressed that US firms were seeking more improvements in the local business climate.

Vietnam is to become the 2nd Asian nation to be recognized by the International Cocoa Organization (ICCO) as a "fine flavor" cocoa origin. Vietnam produces cocoa on more than 11,000 hectares in three cocoa-growing regions: Western Highlands, Mekong Delta, and Southeastern Region. ...





### WTO Trade Facilitation Agreement: What businesses need to do

"Vietnam Customs currently has 500 documents with 5,000 requirements, characterized by '9 nots' ... not clear, not efficient, not effective, ... etc." (Mr. Nguyễn Đình Cung, Director, Central Institute for Economic Management)



### Unions in transition: Industrial Relations in Vietnam

Most experts ascribe a large part of the responsibility for the lack of efficient dispute resolution, to the VGC, which brings enterprise unions and industry unions together under one umbrella organization. So far, the VGCL has reacted only cautiously to work stoppages. The main problem - the lack of a genuine representation of workers' interests - remains untouched. As long as inflation can be maintained at a constantly low level and real wages manage not to fall, the conditions seen in 2011 will not materialize again. If another economic slump were to hit again though, vast numbers of work stoppages might well become common once again.



### Democratic Senators' Letter to U.S. Trade Representative re Labour

"Senator Melendez and 18 other Democratic Senators recently wrote to U.S. Trade Representative Froman, "It would be premature for Congress to take action on TPP before Malaysia, Vietnam, and Brunei have taken the first steps toward fulfilling their commitments [in the Labor Chapter and the bilateral consistency plans]. ... implementing legislation for the TPP should not be submitted to congress until Malaysia, Vietnam, and Brunei have met the obligations stipulated in the consistency plans."



### U.S. remains the leading source of FDI

globally, according to the OECD. Data shows U.S. FDI outflows accounted for 39.5% of all OECD FDI outflows in 2013, and 37.6% of all OECD FDI outflows in 2014, the most recent year for which data is available. And over the years, U.S. has accounted for 44% of the OECD FDI "stock" by 2014. OECD FDI outward flows in 2014 were \$895.428 billion, of which U.S. FDI outward flows were \$336.935 billion, or 37.6%.

## Sander Levin, Top House Democrat on trade, opposes TPP

The leading House Democrat on trade policy said he opposes the TPP, underscoring the hostile political environment. He said he doesn't support the TPP in its current form because it contains insufficient provisions to protect labor, lacks binding rules to prevent currency manipulation, and could ease the movement of the auto industry from his home state of Michigan to Mexico.



## Finance Committee Chairman explains process of TPP ratification

The signing ceremony ... is just beginning. We'll debate the merits of each and every provision of this agreement and consider how it will impact workers and job creators in our country and how it will affect the health of our economy. I will focus on the process by which Congress will consider and debate this agreement ... it is important that people, including members of Congress, the administration, stakeholders, and the media, have a full understanding of how this is going to work. As I've said many times, the TPP is an extremely important agreement, and we need to get it done. But, given that importance, we need to focus more on getting it right than on getting it done fast.
