TPP is coming: [Draft] Statement of Administrative Action submitted to Congress

The White House put Congress on notice that it will be sending lawmakers a bill to implement the Trans-Pacific Partnership agreement - a move intended to infuse new energy into efforts to ratify the trade pact.



TPP Agreement Implementation Act and [Draft] Statement of Administrative Action

This Statement of Administrative Action is submitted to the Congress in compliance with section 106 (a)(1)(E)(ii) of the Bipartisan Congressional Trade Priorities and Accountability Act of 2015 ("Trade Priorities Act") and accompanies the implementing bill for the free trade agreement , known as the Trans-Pacific Partnership Agreement. The bill approves and makes statutory changes strictly necessary or appropriate to implement the Agreement.



Textile giant Texhong is charging ahead in Vietnam, despite TPP uncertainties

For Texhong Textile Group, even as uncertainty looms over the free trade pact, the company is firmly committed to further expansion in its southern neighbor. Texhong, one of the world's largest yarn suppliers, has been aggressively building up production capabilities in TPP signatory Vietnam. Founder and Chairman Hong Tianzhu has said one of the main intentions of investing there is to deal with the trade agreement. But even without the TPP, the competitiveness of the Vietnam operation "is very strong, among all Southeast Asian nations and even compared to Chinese production bases."



Senegal, Uruguay ratify Trade Facilitation Agreement

Senegal and Uruguay have ratified the WTO's Trade Facilitation Agreement (TFA). The submission of the instruments of acceptance means that nearly 85% of the ratifications needed to bring the TFA into force have now been received.





Administration readies one last push for TPP in lame duck session

Although the administration's push will begin in September, no vote will occur until after the Nov 8 elections. Just as the White House Democrats and congressional Republicans mostly agree on the economic benefits of trade, they have parallel political interests in delaying debate. Republicans do not want to provoke attacks from their presidential nominee, Donald J. Trump or hurt other Republican candidates. Mr. Obama does not want to make trouble for the Democratic nominee, Hillary Clinton, who has struggled to persuade voters of her sincerity in switching from support of the pact to opposition.



"Country-specific implementation plans ... to develop political support for TPP" - Senator Hatch

"It is essential that the Obama administration work to reach country-specific plans identifying the changes that our trading partners must and will make to their laws, regulations, and practices in order to meet their key TPP obligations. These country-specific implementation commitments would provide a valuable tool for resolving shortcomings and ambiguities in the agreement, while helping to build confidence in the Congress that TPP will be implemented fully and faithfully by our trading partners.



A fisheries dispute in the East Sea (South China Sea)

Although the East Sea (SCS) covers only 2.5% of the Earth's surface, it comprises some 12% of the total global fish catch. Unfortunately, the region's fisheries are in serious jeopardy. As of 2008, virtually all SCS fishery stocks were collapsed, over-exploited, or fully-exploited. The situation is worsening. The most important aspect of the disputes is not oil or sovereignty-it is whether or not SCS fish continue to appear on Asia's menus.



TPP Prospects in the U.S. Congress Lame Duck Session

"Everything in Washington is impossible until it is inevitable," Ambassador Froman said. But House Speaker Paul Ryan said on Aug 4 that TPP won't get a vote in Congress this year because there isn't enough support. He said there is no point in bringing up the TPP after the November elections because he doesn't see how the Obama administration can build enough support for the agreement. Nevertheless, the Administration is making a "whole of government" effort to pass the TPP this year



Officials urge tighter food safety control

Chairman of Ha Noi Supermarkets Association Vu Vinh Phu said that more attention should be paid to the production stage with solving problems of production factors like air, soil and water. A recent conference showed that in the first half of this year, almost 4% of vegetables had excessive concentrations of pesticide, 1.3% of meat contained excessive concentrations of chemicals, and 5.3% of aquaculture products had excessive antibiotics residue.



Consultations begin on 2017 Minimum Wage

At a meeting in Haiphong on July 22, the council's technical department proposed increases of 9.7-10.4%, 8.6%, and 7.1-8.3%. Vu Duc Giang, chairman of the Vietnam Textile and Apparel Association (Vitas), member of the council, stressed that the minimum wages should not go up in 2017 as textile and garment firms are now struggling with increasingly high input costs. "Textile and garment firms cannot expand investment and production if minimum wages are adjusted up again. This will lead to massive layoffs. Who will be responsible for this?" Giang said.



**U.S. Customs and
Border Protection**

CBP offers classification and valuation assistance program to U.S. exporters

U.S. Customs and Border Protection will provide technical assistance to help U.S. exporters resolve issues involving tariff classification and customs valuation treatment by other customs administrations. There have been cases where, through erroneous or inappropriate application of customs valuation principles or misinterpretation of classification rules by customs services in countries of import of U.S. exports, such actions have acted as non-tariff trade barriers to U.S. goods. These have often given rise to serious disputes and costly appeals. Under the new CBP program, technical assistance may be provided in appropriate cases by CBP's Office of Regulations and Rulings through review of the technical issues and, if appropriate, bilateral consultations with the customs administration involved.



U.S. Labor Department accepts petition alleging that Columbia is not complying with Labor Action Plan

Congressional labor champions cheered the Labor Department's decision Friday to accept a petition filed by U.S. and Colombian labor unions alleging the South American country is failing to comply with labor rules under its free trade deal with the U.S. "Labor provisions in our free trade agreements with other countries mean nothing if they are not enforced," said Sen. Sherrod Brown (D-Ohio). "It's clear Colombia has ignored labor violations and failed to uphold the agreement's protections for workers who want to organize. Today's decision by DOL sends a signal that the U.S. is committed to rooting out mistreatment of workers and raising labor standards around the world."



WB report: Vietnam's pension system facing serious challenges

According to WB experts, the official pension system is facing major challenges which will become increasingly serious when the aging process accelerates. Currently, the population aged 65 and older in Vietnam is 6.5 million, but the number is expected to increase by 3 times to 18.4 million by 2040. In 2014, Vietnam made reforms but they were not fast and powerful enough to restore financial balance of the retirement fund. Before the amendment, economists forecast that the fund would be in deficit in the early 2020s and the reserves will be exhausted by mid-2030.
