"The U.S. is not changing China's status as a non-market economy"

a senior U.S. administration official said in an interview. "China's protocol of accession to the WTO doesn't require the U.S. or any other WTO member to automatically grant China market-economy status after December 11, 2016." China contends Washington and other members of the World Trade Organization should grant it market-economy status on Sunday, the 15th-anniversary of its WTO accession, under the terms of its joining the group.



Vietnam visitor visas for U.S. citizens - price confusion

What is the cost of a Vietnam visa? It varies. The Vietnam Embassy's website (www.vietnamembassy.us) doesn't list prices. It simply directs people to an email address and a phone number with multiple extensions. The Vietnamese government allows some businesses and travel agencies to arrange for preapproval for a "visa on arrival" at the airport, but the State Department warns that some U.S. citizens have reported being charged unexpectedly high fees upon landing in Vietnam. It recommends that travelers get a visa directly from an embassy or consulate of Vietnam prior to arrival.

TET Lunar New Year, 2017 . Jan 26 - Feb 1 - Seven Days

Traditionally, there are several main days of celebration: Tết Lunar New Year's Eve (Jan 27), and The First (Jan 28), Second (Jan 29), and Third (Jan 30), Fourth (Jan 31), and Fifth (Feb 1) of Tết Nguyen Đán. Vietnamese traditionally celebrate Tết from the fifteenth day of the twelfth lunar month to the fifteenth day of the first lunar month. And, even today, business slows two weeks before and two weeks after TET. The official 2017 TET Holidays in Vietnam are from Thu, Jan 26 to Wed, Feb 1 inclusive.



President's long-forgotten power to raise tariffs

There is a long forgotten but still intact statute that provides the President with broad tariff-setting authority. This authority, Section 338 of the Tariff Act of 1930 [Smoot-Hawley Tariff Act], is not mentioned in the "Overview and Compilation of U.S. Trade Statutes" published annually by the U.S. Congress. And although Section 338 has gone unused for decades, it remains on the statute books and is available to the president.



FedEx CEO suggests revised TPP, with improvements

in a speech in Washington on Dec 9. There are two important takeaways from the speech. (1) it shows that the corporate establishment is going to take a hardline on issues like NAFTA. Smith made a vigorous defense of the TPP agreement. (2) Republican members of the House voted 190 to 50 in June 2016 to give the President "Trade Promotion Authority" for TPP, which shows that free trade deals are popular with Republicans. With Democrats out of power in Washington, and Trump's administration increasingly staffed by establishment figures, the President-elect could have a lonely fight on his hands if he attempts to dismantle the free-trade status quo.



World Bank: Structural reforms remain critical to Vietnam's growth

Thanks to robust domestic demand and export-oriented manufacturing, Vietnam's medium-term outlook remains favorable, with GDP expected to expand by 6% this year. Vietnam's growth was accompanied by low inflation and widening current account surplus. Risks that could adversely affect medium term prospects include perennial delays in implementation of structural and fiscal reforms.

TPP is not dead: Sen. Orrin Hatch, Rep. Kevin Brady, Rep. Dave Reichert

President-elect Trump said he would withdraw from TPP on his first day in office. Japan's PM Abe said the TPP would be meaningless without U.S. participation. House Ways & Means Chairman Kevin Brady, Trade Subcommittee Chairman Dave Reichert, and Senate Finance Committee Chairman Orrin Hatch say TPP is still possible. Asked how he plans to persuade Trump to reconsider his stance on the Asia-Pacific deal, Hatch said, "well, I'm fairly persuasive sometimes."



Vietnam's 2017 Minimum Wage Decree

Vietnam's Minimum Wage Adjustment for 2017, the fourth since the establishment of the National Wage Council under the revised Labour Code of 2012, is an average increase of 7.3%, down from 12.5% in 2016. It was announced in Decree 153/2016/NĐ-CP, 14/11/2016, and will go into effect on Jan 1, 2017. One difficulty: enterprises' expenditures will increase sharply, because they not only must adjust monthly salary for their workers but also must increase their contribution to social insurance. At the present, total social insurance takes up 32% of monthly salary, of which employers must pay 22%.



ILA Vietnam - education training centers

HPEF Capital, formerly Headland Capital Partners, and other shareholders of Vietnam-based education company ILA Vietnam are seeking to sell the business for \$150 million. First-round bids will be made by the end of this year, according to a Bloomberg report.



After the Trans-Pacific Partnership, a perspective from Vietnam

President Obama has announced that he will no longer seek passage of the Trans-Pacific Partnership (TPP) in Congress, leaving the fate of the treaty in the hands of President-elect Trump and the Congressional Republican leadership.

This matters for two reasons. First, within a decade, four of the five largest economies of the world will border the Pacific Ocean. The United States will be able to continue its global leadership role only if it retains an integral, active presence in the Pacific. Second, if the United States retreats from the region, as a defeat of TPP in Congress would surely signal, an emboldened China will ever more aggressively seek to displace America.



Vietnam to apply extensive area code changes in 2017

Area code changes in Ho Chi Minh City, Hanoi, Dong Nai, Binh Duong, and a number of other provinces will take place on June 17, 2017. The new area codes will be applied for 59 cities and provinces in three phases, from February 11 to June 17, with steps taken to ensure the change will not confuse the public, the Ministry of Information and Communications announced. But there are other concerns, such as the need to reprint packaging or business cards once numbers are changed, costing quite a sum.
