President Trump will visit Vietnam for the November APEC Leaders meeting, in response to Vietnam President Tran Dai Quang's invitation, U.S. Secretary of State Tillerson and National Security Council (NSC)Advisor McMaster confirmed to Deputy Prime Minister and Foreign Minister Pham Binh Minh during his official visit to Washington on Apr 20-21. NSC Advisor McMaster also conveyed President Trump's invitation to Prime Minister Nguyen Xuan Phuc to visit the U.S.



USDA Inspection of Siluriformes fish, including catfish, full enforcement from Sep 1, 2017

After an 18-month transition period, full enforcement of USDA inspection of siluriformes fish, including catfish will begin on Sep 1, 2017. According to some Vietnam news reports, "the change will have potentially disastrous consequences for Vietnam catfish producers, because while the FDA does spot checks on a small sample of imports as they arrive, the USDA requires on-site inspections of production facilities. For countries like Vietnam, setting up an equivalent system could take years and effectively cripple the industry."



GE's Energy Ecosystem to help meet Vietnam 2030 power targets

The GE Energy Ecosystem portfolio has been unveiled at the Powering Vietnam conference in Hanoi, resonating interconnected system of digital and industrial technologies with country's energy agenda to deliver affordable, reliable, and more sustainable production, distribution, and consumption of energy.



Made-in-Vietnam energy plan aims for investment

Foreign tech firms are showing what can be done with renewable energy farms and micro-grids for industrial parks, solar, and "smart city" technology in Vietnam. John Rockhold, head of the Vietnam Business Forum's Power and Energy Working Group, pointed out how new technology is making renewable energy more affordable than ever, and putting it in the grasp of the national power grid.



FDI attraction up 40.5% in four months

As of April 20, as many as 734 newly-registered projects were granted with investment certificates with a total registered capital of US\$4.88 billion, equal to 96% of the same period last year, according to the Foreign Investment Agency, under the Ministry of Planning and Investment.



SMEs find strong partner in \$25 million government fund


A number of firms have started to look for help from the Small and Medium Enterprise Development Fund (SMEDF) after its first year of operation.

U.S., Australian Food Safety Systems are "comparable"

The U.S. Food and Drug Administration has signed an arrangement with the Australian Department of Agriculture and Water Resources recognizing each other's food safety systems as comparable to each other. This is the third time that the FDA has recognized a foreign food safety system as comparable, the first being New Zealand in 2012 and Canada in 2016.



U.S. FDA accepts D-U-N-S® Number for Foreign Supplier Verification Program

The FDA issued guidance formally recognizing the Data Universal Numbering System (DUNS) number as an acceptable unique facility identifier (UFI) for FSVP. The identification of importers will help the FDA effectively implement, monitor compliance with, and enforce the FSVP requirements, which are designed to help ensure that imported foods meet U.S. safety standards. ...



US\$265m for smart traffic operation centre

A smart traffic operation centre in HCM City will receive an investment of VND6 trillion (US\$265 million) from 2017 to 2020, the city's Department of Transport has said. In the first phase of the project, about VND250 billion (\$11 million) will be allocated to upgrade the existing traffic operation system.



IMF, WTO, OECD vow to defend free trade against protectionism

The chiefs of the IMF, WTO and OECD vowed on Monday (Apr 10) in a joint statement to defend free trade against creeping protectionist trends, amid growing global alarm over US President Donald Trump's "America First" call.



Preparations on track for APEC Danang

Vietnamse President Tran Dai Quang lauded the work of government agencies and the authorities of Danang to prepare for the APEC Summit 2017 and asked that they ensure a secure and successful event that would show to the world a good image of Vietnam.



Decision paves way for solar power development

Opportunities to invest in Việt Nam's solar energy sector are abundant after Prime Minister Nguyễn Xuân Phúc issued a decision to encourage the development of solar power projects. Under Decision 11/2017/QĐ-TTg, which takes effective from June 1, 2017, all output produced by solar power projects will be purchased for VNĐ2,086 (US 9.3 cent)/kWh (excluding VAT) - a profitable rate for investors.



Executive Order re Report on Significant Trade Deficits

The Secretery of Commerce, together with the U.S. Trade Representative and other agencies will prepare a Report on Significant Trade Deficits within 90 days, by the end of June. The study will look at the countries primarily responsible for the U.S. trade deficit,, including China, Japan, Germany, Mexico, Ireland, Vietnam, Italy, South Korea, Malaysia, India, Thailand, France, Switzerland, Taiwan, Indonesia and Canada. Surprisingly, the U.S. trade deficit with Vietnam (\$32 billion) is larger than that with South Korea (\$28 billion).



Trump, China President Xi meet to chart a way forward for the U.S. s-China Relationship

A Background Briefing by Senior Administration Officials on the Visit of President Xi Jinping of the People's Republic of China focused on the opportunity for the two leaders to exchange views on each other's respective priorities and to chart a way forward for the U.S.-China bilateral relationship.



Trump, China's President Xi have "very candid, very positive" talks

President Donald Trump and Chinese President Xi Jinping established a new framework for high-level negotiations on a range of issues and pledged to make progress on trade negotiations within the next 100 days, top US officials said. China Daily said both parties appeared "equally enthusiastic about the constructive relationship they have promised to cultivate.



Secretaries of State, Treasury, Commerce discuss Trump-Xi talks

Secretary of State Tillerson. I think what I would really want you to get a grasp of is that both the atmosphere, the chemistry between the two leaders was positive. The posture between the two really set the tone for our subsequent meetings between our high-level delegations. And I would tell you the exchanges were very frank. They were candid, they were open, and they were very positive. So I think all of us are feeling very good about the results of this summit in terms of what it did for setting a very constructive tone going



Decision on the Support mechanisms for the Development of Solar Power Projects in Vietnam

was signed by Prime Minister Nguyen Xuan Phuc on April 11, 2017. This Decision regulates the mechanisms for promoting the development of solar power projects in Vietnam.



Blog: Does U.S. medical research subsidize other countries?

Leading U.S. business and political leaders strongly believe that without adequate IP protection important U.S. industries would be undermined, and many high-technology jobs and companies would disappear. The U.S. produced 57% of the world's new medicines between 2001 and 2010, up from less than a third in the 1970s, the Milken Institute reported in 2011.



TPP may not be entirely dead

U.S. to pursue bilateral FTAs with key TPP partners. President Trump's USTR nominee, Robert Lighthizer, told the Senate Finance Committee in questions for the record following his confirmation hearing in mid March that "The President has made it very clear that he intends to promote American leadership in the Asia-Pacific through many channels, including by pursuing bilateral FTAs with our key TPP partners. I support that approach."



U.S., Vietnam renew trade dialogue during Trade and Investment Framework Agreement (TIFA) Meetings

The United States and Vietnam met on March 27-28 under their Trade and Investment Framework Agreement (TIFA) to discuss deepening trade ties between the two nations as well as address outstanding bilateral trade issues. The United States also used the meeting as an opportunity to reaffirm the Trump Administration's commitment to expanding ties with the Asia-Pacific region, including with Vietnam. Agriculture and Food Safety and other working groups were established.



A new paradigm for Asia-Pacific Trade ...?

Wendy Cutler, vice president of the Asia Society Policy Institute and a former diplomat and negotiator in the Office of the U.S. Trade Representative, tells us what to expect from the meetings in Chile. As Acting Deputy U.S. Trade Representative, Cutler played a major role in forming TPP - particularly with the bilateral negotiations with Japan.



Vietnam to apply extensive area code changes in 2017

Area code changes in Ho Chi Minh City, Hanoi, Dong Nai, Binh Duong, and a number of other provinces will take place on June 17, 2017. The new area codes will be applied for 59 cities and provinces in three phases, from February 11 to June 17, with steps taken to ensure the change will not confuse the public, the Ministry of Information and Communications announced. But there are other concerns, such as the need to reprint packaging or business cards once numbers are changed, costing guite a sum.
