"Reasonable chance" for TPP at APEC 2017

After US President Donald Trump announced the US' withdrawal from the Trans-Pacific Partnership (TPP) Agreement, history's largest trade deal to date congregating around 40 per cent of the world's economy seemed to have fallen through. However, the eleven remaining member states decided to go ahead with the deal and may well reach a revised agreement at APEC Vietnam this November.

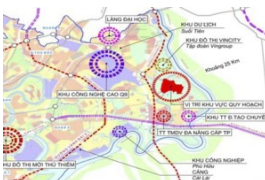
MoIT scraps nearly 500 hydropower projects

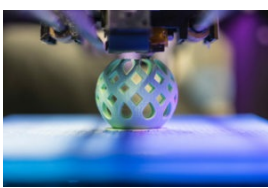
Foreign investment in Vietnam may reach \$28 billion by end of 2017

By the end of 2017, Vietnam will see soaring foreign investment capital, reaching \$28 billion with an expected record in disbursed FDI capital of \$17 billion.



HCM City to build 200ha science and technology park

The HCM City People's Committee has approved the 1/2000 scale plan for the city's second science and technology park to be built in District 9 at a cost of around VNĐ4.3 trillion (US\$188 million). To come up in Long Phuoc Ward near the Hi-Tech Park, the 200ha park will have distinct zones for research and application of advanced technologies, fabrication of high-quality products, incubation of start-ups and high-tech training for workers.



How 3-D Printers Could Erase a Quarter of Global Trade by 2060

Critics of global trade might find something to celebrate in the advent of 3-D printing. Raoul Leering, head of international trade analysis at ING, writes that growth in 3-D printing could wipe out almost one-quarter of cross-border trade by 2060. His review of the technology's landscape kicks off this week's economic research wrap, which also touches on innovation clusters, attitudes about men and women in the American workplace, and the demographics of art spending. Revitalising Vietnam's power plants, keeping an eye on emissions
