Nebraska native Daniel Kritenbrink confirmed as U.S. Ambassador to Vietnam

WASHINGTON - The Senate on Thursday confirmed Nebraska native Daniel Kritenbrink to be the U.S. Ambassador to Vietnam.

A diplomat since 1994, Kritenbrink served as senior director for Asian affairs for President Barack Obama's National Security Council. Before that, he was deputy chief of mission in Beijing.



Foreign investment hit over US\$28 billion in 10 months

As of October 20, Vietnam has attracted US\$28.24 billion in foreign direct investment (FDI) capital, a year-on-year increase of 37.4%, according to the Foreign Investment Agency under the Ministry of Planning and Investment.

Of the figure, US\$16.3 billion was put into 2,070 new projects (up 32.9%), US\$7.27 billion (up 35.9%), into 1,001 operational projects that demand additionally increased investment capital and US\$4.67 billion into 4,156 capital contribution and share buying projects.



US president's visit galvanises firms

As the US and Vietnam seek to deepen economic ties, US President Donald Trump's upcoming visit to Vietnam is expected to create a positive attitude among the US business community, which is likely to unlock further bilateral trade and investment opportunities. Thanh Van and Tung Trang report.



U.S. gains second largest tax sum from Vietnam exporters

HCMC - Total tax collections by the U.S. from Vietnamese exporters take the second position after China although Vietnam ranks 12th among the largest suppliers of commodities to the world's largest economy, an American expert said yesterday.

US\$2.2 billion in duties in the year to August. During this period, Vietnam exported goods worth over US\$30.16 billion to the U.S., accounting for a mere 1.99% of America's total imports.
