Fruit exports to US get Trump boost

US President Donald Trump's state visit to Vietnam last month helped to open the door wider for Vietnam's fruit exports, further strengthening the two nations' agricultural co-operation. The US Department of Agriculture's Animal and Plant Health Inspection Service (APHIS) announced that it will soon allow the importation of fresh mango from Vietnam into the continental US, effective December 29, 2017.





Strong second half of year results in big trade surplus

Vietnam has enjoyed a record 11-month trade surplus, reflecting a strong second half of the year in firms' export-import performance.

The General Statistics Office reported that, overall, the economy witnessed a record trade surplus of \$2.75 billion in the year's first 11 months.

Deputy Prime Minister Vuong Dinh Hue called for speeding up the equitisation of State-owned enterprises (SOEs) at a meeting of the Steering Committee for Business Renovation and Development on Thursday.



Nafta Round Closes With Talks Bogged Down by Conflict

WASHINGTON - United States officials have tried in recent weeks to cool tensions over the North American Free Trade Agreement by extending the timetable for renegotiating the pact and asking top officials to sit out the current round of talks in Mexico City.
