



93%	Trade & customs regulations (FTZ, cross-border, single-window)	
92%	Optimizing supply chain costs

90%	Regulations for services providers (logistics, transport, freight forwarding, etc)	
82%	FTAs impacts on Vietnam (U-turns, COOs, etc)	
79%	Warehousing / cold storage	
78%	Challenges of short haul v. long distance shipments	
78%	Air / shipping / ports	
75%	Consumer goods (sector-related topic)
