Novel Coronavirus (COVID-19, aka 2019-nCoV) Update

AmCham held a February 6 Business Intelligence Briefing on the Health and Business Impact of Novel Coronavirus in Vietnam with a series of expert panelists, including:

Survey participants at our event reported that 79 percent were very concerned about the health impact of the outbreak, while 71 percent were very concerned about the business impact.
