The election for the 2020 AmCham Vietnam-HCMC Board of Governors will take place through online voting starting in mid-November and will be announced on December 15. There are 10 positions open on the Board. AmCham Vietnam-HCMC seeks candidates willing to actively serve for a two-year term, Jan 2021 - Dec 2022.

If you want to be considered as a possible candidate for the Board, or recommend someone to be considered, please submit the recommendation form below to the AmCham Vietnam-HCMC Nominating Committee no later than **October 18**.

### **WHO CAN SERVE, RECOMMEND FOR NOMINATION & VOTE?**

- Any U.S. citizen that is a member of AmCham regardless of membership category.
- Non-U.S. citizens who are Designated Representatives or Additional Members of a Company Member which is a U.S. entity or which has substantial investment or operation interest held by U.S. legal entities or citizens.
- Non-U.S. citizens of AmCham Member NGOs (non-governmental organizations) that are established or formed in the United States.

Note: Non-resident, and Honorary Members of AmCham are NOT eligible to vote.

## **THE CRITERIA FOR GOVERNORS INCLUDES:**

- Willingness and ability to commit time and resources to Board of Governors work;
- Experience and senior status within their company or business;
- Representation of industry sector, company status, and size which helps achieve diversity and balance, including a majority of members representing U.S. companies;
- Gender diversity; and
- Representation of individuals with diversity of Vietnam-specific, as well as regional and global expertise.

## **OTHER INFORMATION ABOUT THE PROCESS:**

Incumbent Board Members are requested to confirm in writing that they would like to be considered for re-nomination and must submit the same requested information as non-incumbent recommended persons.

All interested persons recommended (by themselves or by others) (including incumbent board members interested in re-nomination) are required to provide the following information by October 23, 2020:

- biographic information with digital photo (150 word max. length)
- resume
- statement of interest, including description of past AmCham experience, your "vision for AmCham" in the future, and what you will do to make that possible (150-word max.)

Please note that this is a recommendation only, and that a person recommended providing the above information must also be nominated by the Nominating Committee, which will hold meetings and finalize a list of nominees on or about the week of October 30, 2020.

All nominees selected by the Nominating Committee will be invited to participate in a Meet the Candidates Night on Tuesday, November 17, 2020, which will be open to Voting Members.

Secure online voting will be open on or about November 15, 2020 to all eligible Voting Members.
