Requested that the American Chamber of Commerce in Vietnam to organize activities in accordance with Decree No. 08/1998/ND-CP, dated 22 January 1998 of the Government of Vietnam Promulgating the Regulations on the Establishment of Foreign Business Associations in Vietnam; License no. 02/GP-HHND/HCM issued on September 19, 1998 by the People's Committee of Ho Chi Minh City on "License for the Establishment of a Foreign Business Association in Vietnam"; Charter of The American Chamber of Commerce in Vietnam which was approved by the People's Committee of Ho Chi Minh City; and at the same time, there is a report to the People's Committee of Ho Chi Minh City on the establishment of the Branch in Đà Nẵng city.
3. In the process of organizing and operating, suggested that the American Chamber of Commerce in Vietnam and the Branch in Đà Nẵng city actively coordinate with the Department of Industry and Trade of Da Nang city for guidance and support.
